The amounts reflected are cumulative.</p> <p>Jobs Estimated - Estimated number of positions funded to support or carry out Recovery Act projects and activities. The number is expressed as "full-time equivalent" (FTE), calculated quarterly as all hours worked in the reporting quarter divided by the total number of hours in a full-time schedule in that quarter. Note: A change in federal guidance changes the job estimate calculation from a cumulative to a quarterly perspective. Additionally, previous federal guidance required recipients to make a subjective judgment on whether a given job would have existed were it not for the Recovery Act. The updated guidance eliminates this subjective assessment and defines jobs created or retained as those funded in the quarter by the Recovery Act.
